February 4, 2025: Behavior Based Safety

94% of all injuries are rooted in unsafe behaviors. The goal is to easily break down what behaviors contributed, and how you can influence them. It could be as simple as finding the correct tool, getting the correct size PPE, or discussing "why" there are policies in place. If you only focus on conditions, you can expect to impact only 6% of your loss history.

Without accountability, there is no committed speech, there are no promises and no declarations. Therefore, there are no breakthroughs. There is, at best, business as usual or the status quo. Trailing indicators are important but if you are looking to improve areas of safety, why not use leading indicator metrics such as % safety training completed, % of employees directly involved in safety, or % of injuries investigated within allotted time? “What gets measured, gets done”!
